The Commission is glad to inform you that, The International Organization of Securities Commission (IOSCO) has scheduled fifth World Investor Week (WIW) from 04 October to 10 October. In line with IOSCO Bangladesh Securities and Exchange Commission is going to observe the World Investor Week 2021.

The Key messages of the IOSCO World Investor Week Campaign in 2021 are based on the two themes: 1) Sustainable Finance, 2) Fraud and Scam Prevention. These messages compliment such online investing, initial coin offerings, the basics of investing and digital learning and online education.

Based on these themes Bangladesh Securities and Exchange Commission is also going to launch the World Investor Week from 04 October 2021 to 12 October 2021 with participation of the capital market stakeholders, intermediaries, stakeholder's association, investors and other participants.
